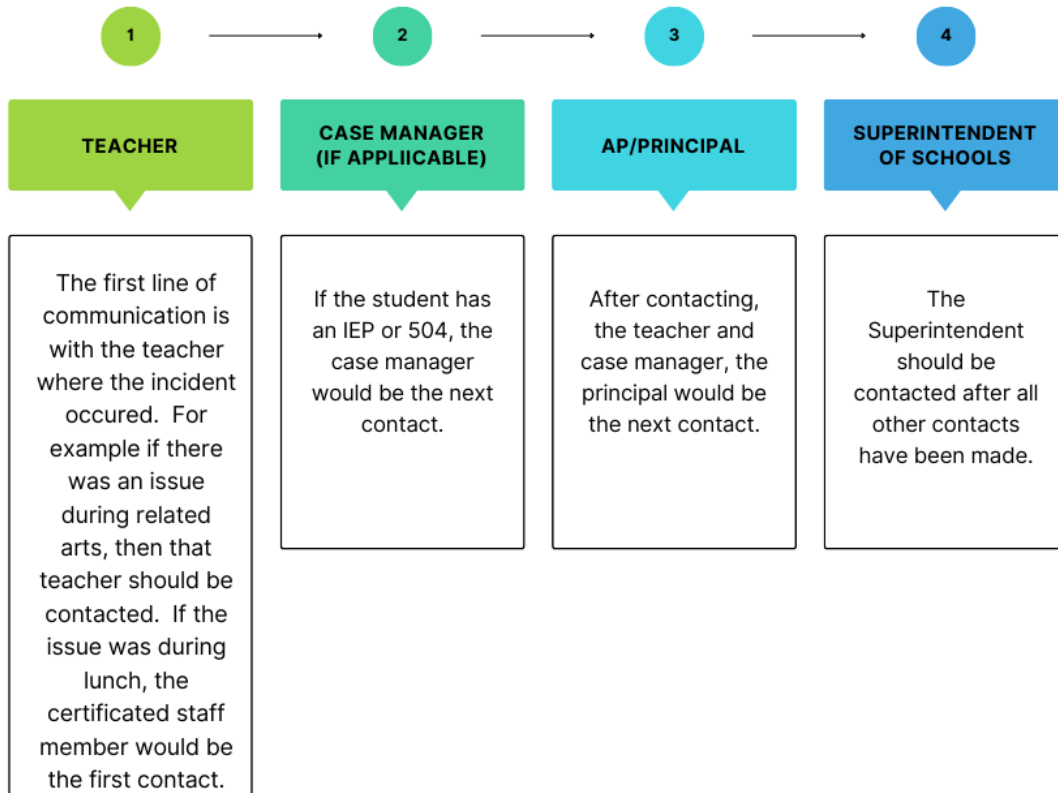

## UNIVERSAL EXPECTATIONS

Our students are expected to:

- Arrive to school on time each day
- Follow all classroom rules and expectations
- Be organized and prepared for class each day
- Give maximum effort
- Use appropriate language
- Choose actions and words that are kind
- Keep hallways clean and quiet
- Keep our school free from vandalism
- Take care of school materials, equipment and property
- Be helpful to others
- Be accountable for your words and actions

## LUNCHTIME EXPECTATIONS

- Enter the cafeteria in a quiet and orderly fashion
- Remain seated

- Sit at the table without crowding the other children
- Use good manners
- Speak in a soft, inside voice
- Do not share or trade food
- Clean up after yourself before being dismissed
- Listen to and respect the adults in charge

## **PLAYGROUND / RECESS EXPECTATIONS**

- Dress appropriately for the weather
- Follow the directions of the adults in charge
- Play in the designated areas only
- Do not leave the recess area
- Avoid rough activities such as pushing, wrestling, tackling or play fighting
- Include all children who want to play
- Share playground equipment and supplies
- Use playground equipment in the manner for which it was intended
- Tell an adult immediately if someone gets hurt
- Tell an adult immediately if someone is bullied or harassed
- When recess is over stop playing and line up immediately in your class's designated area

## **CELL PHONES, CAMERAS, PERSONAL ELECTRONIC DEVICES, TABLETS, SMART WATCHES VIDEO, VOICE RECORDERS, AND ANY OTHER WiFi OR CELLULAR ENABLED DEVICES**

Students may not use cell phones, smart watches or similar devices on school property during school hours. If students bring a cell phone or wear a watch with cell phone capability, it must be set to silent and kept in their locker/cubby. In addition, any device that records video images or voices is not permitted on school grounds or on field trips. The clear intention here is to respect privacy rights. Students who photograph or capture images of other students on school property with or without their permission will be referred to the school administration for appropriate action. Lunch, recess, and other play times are meant to be pleasant, socially interactive daily activities. Electronic devices are not permitted for use during this time.

## **USE OF TECHNOLOGY RESOURCES**

The River Edge School District affords all students access to meaningful technology resources that advance and promote learning. Proper student etiquette, both at school and at home, is the responsibility of each and every student. It is important to note that the use of such resources is a privilege, not a right. Students are to use technology resources only in productive ways to promote the learning process as supervised by the classroom teacher. In addition, students should never post/share personal information about themselves on the internet (i.e., names, addresses, telephone numbers, or personal photographs) or send harassing messages using electronic mail and/or other forms of communication. Furthermore, students shall not attempt to gain unauthorized access to the District system or any other computer system through the District system, nor shall they go beyond their authorized access. This includes attempting to login through another individual's account or accessing another's files. Students shall not deliberately try to disrupt the District's computer system performance or destroy data by spreading computer viruses that can damage computer systems,

## **HOMEWORK EXPECTATIONS**

The purpose of homework is to reinforce and extend learning, develop independent study habits, and foster responsibility and time management skills. It serves as a tool for students to practice and apply what they have learned in the classroom.

The amount of homework assigned will be appropriate for the grade level and individual needs of the students. Typically, homework will be assigned Monday through Thursday.

### **SUGGESTED GUIDELINES**

Kindergarten 5-10 minutes 3-4 times a week  
Grade 1 10-15 minutes 3-4 times a week  
Grade 2 10-30 minutes 3-4 times a week  
Grade 3 20-40 minutes 3-4 times a week  
Grade 4 30-60 minutes 3-4 times a week  
Grade 5 40-60 minutes 3-4 times a week  
Grade 6 45-75 minutes 3-4 times a week

## **Parental Involvement**

Parents and caregivers play a crucial role in supporting their child's learning process. They are encouraged to:

- a. Create a conducive homework environment that is quiet, well-lit, and free from distractions.
- b. Establish a consistent homework routine, setting aside dedicated time for completing assignments.
- c. Provide necessary guidance and support, without completing the work for the child.
- d. Monitor their child's progress and communicate with teachers if any difficulties arise.

## **Homework Expectations**

Students are expected to:

- a. Complete all homework assignments to the best of their ability and submit them on time.
- b. Demonstrate independent effort and take responsibility for their work.
- c. Seek clarification from teachers if they have any questions or need additional support.
- d. Maintain organization by keeping track of assignments, materials, and due dates.

## **DRESS CODE**

To provide a safe and secure school, strengthen the educational focus, and establish an orderly learning environment while preparing students for success in the professional workplace, the following standards for student dress and appearance must be adhered to.

- Clothing that exposes the mid-section of the body (midribs or undergarments) are not permitted.
- Any clothing articles that reveal undergarments are not permitted. This includes, but is not limited to, bralettes, camisoles, form-fitting tank tops, boxer shorts, underwear, etc.
- Skirts, dresses, shorts, or "skorts" must cover underwear and extend at least 2 inches below

the buttocks.

- Extremely tight clothing, such as bodysuits/leotards, must be covered with a top layer.
- Clothing may not be adorned by slogans, symbols, or advertising promoting drugs, alcohol, or similarly inappropriate themes.
- Hoods and hats are not permitted except those worn for religious or medical purposes or unless a pre-announced special occasion permits them
- Slippers, open toe footwear, shoes with wheels, flip-flops and high platform shoes are not permitted.
- All footwear must have a supportive backing.
- Sunglasses, or any other eyewear is not permitted unless the lenses are for corrective vision.

## IMPORTANT DEFINITIONS

**Tardiness** – Students will be considered tardy if they enter the building after 8:30 am.

**Lunchroom Misbehavior** – Lunchroom misbehavior includes, but is not limited to disrespecting or not listening to teachers and other students, leaving seats without permission, throwing or trading food, making or leaving a mess, yelling and other inappropriate behavior.

**Physical Confrontation** – Physical confrontation is a dispute, conflict, or physical aggression that may or may not result in injury.

**Physical Assault** - Physical assault is an intentional or reckless act that causes physical harm or bodily injury.

**Cell Phone/Smart Watch** – Any device that can be used to make a text, phone call, and or access the Internet.

**Verbal Misconduct** – Verbal misconduct is a type of emotional abuse that uses language and communication to cause harm.

**Verbal misconduct** includes, but is not limited to:

Teasing: making fun of or laughing at someone

Rumors: spreading false information about someone

Gossip: talking negatively about someone behind his/her back

Name calling: using negative words to describe someone

Profanity: swear words or other inappropriate language

Exclusion: leaving someone out of games and discussion

**Academic Dishonesty** – Not completing your own work on a test or an assignment or copying the work of others.

**Disrespect to an adult** – Includes, but is not limited to, talking back, walking away while being spoken to, not following adults' directions.

**Theft or defacing property** – Taking personal or school property without permission from the owner. Vandalizing personal or school property. Examples include, but not limited to, writing on walls, breaking windows, and intentionally breaking school or personal equipment. If property is stolen or is damaged you are expected to pay for the damage or return the stolen item.

**Accountability** - accepting responsibility and acting to repair harm done.

## HIB – HARASSMENT, INTIMIDATION, AND BULLYING

The River Edge School District has conscientiously implemented the requirements found in the Anti Bullying Bill of Rights Act by providing programs and training opportunities for staff and students to develop strategies for conflict resolution and creating a positive learning environment for all students. ## VIOLATIONS OF THE CODE OF CONDUCT

This plan will be used when dealing with conduct that may or may not rise to the level of HIB. Remedial measures shall be designed to correct problematic behavior, prevent another occurrence of the problem as well as protect and provide support for all students.

We believe in restorative practices where we work with our students to examine the harmful impact of conduct infractions and then determine what can be done to repair that harm while holding students accountable for their actions.

We believe that making mistakes is a part of life and especially a part of growing up. It is the job of teachers, counselors, mental health professionals, and administrators to teach and guide while ensuring the physical and emotional safety of our students at all times.

Administration reserves the right to use their discretion regarding each incident.

## **HARASSMENT, INTIMIDATION, AND BULLYING**

The River Edge Board of Education believes that a safe and civil environment in school is necessary for students to learn and achieve high academic standards. Since students learn by example, school administrators, faculty, staff, and volunteers are required to demonstrate appropriate behavior, treating others with civility and respect, and refusing to tolerate harassment, intimidation or bullying. Harassment, intimidation or bullying, like other disruptive or violent behaviors, is conduct that disrupts both a student's ability to learn and a school's ability to educate its students in a safe environment. Therefore, the school district will not tolerate acts of harassment, intimidation or bullying.

### **Consequences For HIB that are found to be in violation of the HIB policy**

The consequences imposed will be determined by the Principal or Designee based on the specific student and the nature of the incident:

First Offense consequences can include:

1. A copy of the result of the investigation shall be placed in the student's record
2. Restorative actions including, but not limited to, counseling or behavior intervention services
3. Research-based project
4. Detention

Second Offense consequences can include:

1. A copy of the result of the investigation shall be placed in the student's record
2. Restorative actions including counseling or behavior intervention services
3. Research-based project
4. Detention
5. Suspension
6. Parent meeting with student and administration

Third Offense consequences can include:

1. A copy of the result of the investigation shall be placed in the student's record
2. Restorative actions including counseling or behavior intervention services
3. Research-based project
4. Detention
5. Suspension
6. Parent meeting with student and administration
7. May require the student accompanied by a parent or guardian to complete a class or training program to reduce harassment, intimidation, or bullying behavior

### **Consequences For Incidents That Fail To Qualify As HIB, But Result In Code of Conduct Violations**

The degree of sanctions will be determined by the school climate team, Principal, and/or Designee based on the specific student and the nature of the incident:

First Offense consequences can include:

1. Warning administrator or teacher conference with student
2. Teacher conference with student
3. School based counseling
4. Research-based project
5. Administrator conference with student
6. In-school suspension
7. Suspension

Second Offense consequences can include:

1. Administrator conference with student
2. School based counseling
3. Loss of privileges
4. In-school suspension
5. Suspension
6. Parent meeting with student and administration

Third Offense consequences can include:

1. Administrator conference with student
2. School based counseling
3. Loss of privileges
4. In-school suspension
5. Suspension
6. Parent meeting with student and administration
